Mayor Kaplan requested a moment of silence in memory of the individuals that were killed at Sandy Hook Elementary School in Newtown, CT.

Mayor Jeff Kaplan called for the special meeting to discuss a ban on handguns, semi-automatic weapons and assault weapons in the Village. In addition, Mayor Kaplan requested that other Village Mayors and Town Supervisors discuss what they could do to find a way to reduce the occurrence of these atrocities.

Different issues that the Mayor spoke about was security in the school, mental health, local registration of weapons, storage of weapons, ban on certain types of weapons, restriction of firearms in the community and consideration for stronger penalties for illegal guns.

Mayor Kaplan wanted input from our residents in reference to this matter and approximately twenty nine people spoke about this issue. Mayor Kaplan thanked everyone for their input and stated that no action will be taken tonight.
